Cross-certification is available to referees of AYSO and USSF who have been certified as referees for six months or more and who are not certified with both organizations. All games officiated for AYSO or USSF may be applied toward the certification requirements of either AYSO or USSF. The diagonal system of control is the only recognized system of control.

<b>Fees:</b> Referees cross-certifying from AYSO to USSF need to include a check or money order in the amount of \$40, made payable to their state association, to cover the annual fee associated with certification as a USSF referee.	<b>Fees:</b> There are no fees associated with cross-certifying from USSF to AYSO. However, to be covered under AYSO's Soccer Accident Insurance (SAI) and to receive InPlay, AYSO's quarterly newsletter, all volunteers must complete a Volunteer Application Form each year.
